If I am a head of my household and authorized to grant permission to enter upon the premises of my home, I further agree to sign any necessary authorizations permitting the listed entities to videotape/photograph at my home in the event they elect to do so in connection with my application and the participant selection process.

In addition, on behalf of myself, my family, and on behalf of my minor children, if any, agree as follows:

I authorize GGB to investigate, access, and collect information about me, about any of the statements made by me in my application, any supporting documents or any other document that I have signed or do sign in connection with my application to be selected as a participant in the Program, or about any other written or oral statement I make in connection therewith, and hereby waive all rights of privacy or confidentiality that I might otherwise have in such information.
